Development Review Board

Upcoming application(s) for DRB Review:

- Loren Palmer: The applicant is requesting a revision to a previously approved subdivision for the purpose of relocating the wastewater easement from Lot 1 to Lot 2 of the Palmer subdivision in the Agricultural Zoning District. Property Location: 2693 Shelburne Falls Road This application is scheduled for the November 18th DRB meeting.
- *Craig Martin/Neville Companies* Conditional Use Review for the demolition of a pre-1940 accessory structure. Property Location: 10750 VT Route 116 in the Village Zoning District - *This application is scheduled for the November 18th DRB meeting.*
- Town of Hinesburg/Haystack Crossing LLC 2-lot Subdivision Final Plat, Site Plan, Conditional Use for Development in a Flood Hazard Area and Conditional Use for Development in a Stream Buffer The Town of Hinesburg and Haystack Crossing LLC have a proposal for a recreational field area. The reviews necessary include: 2-lot subdivision final plat, site plan, conditional use for development in a flood hazard area and conditional use for development in a stream buffer. Property Location: located on the west side of Route 116 and the south side of Shelburne Falls Road in the Agricultural Zoning District. This application is scheduled for the November 18th DRB meeting.
- Hinesburg Center LLC (Phase II) Sketch Plan Hinesburg Center Phase II is a planned expansion of the existing Hinesburg Center Phase I, a mixed-use development at Vermont Route 116 and Farmall Drive in the Village of Hinesburg. Hinesburg Center II is bound by Patrick Brook and the associated stream buffer to the north, the Creekside neighborhood to the South, and Hinesburg Center I to the east. The Project is bordered to the west by the growth boundary for the village area, although the Project parcel continues into the agricultural zone. Currently the parcel is maintained as an open hay field. This project proposes 18 single-family residential units, 13 single-family attached units and 43 multi-family units consisting of residential buildings and mixed-use buildings. This application is scheduled for the December 16th DRB meeting.
