Motion by Tom Ayer; Seconded by Andrea Morgante and passed 4-0 (Bissonette absent) the Selectboard passed a motion stating that ***Pursuant to Section 12.2 of the Agreement between the Town of Hinesburg and the American Federation of State, County and Municipal Employees, AFL – CIO (AFSCME), the Selectboard is hereby placing Brian Mattison, Wastewater/Water Superintendent, on suspension without pay for a period not to exceed five (5) days and notifying him of the Selectboard’s intent to discharge him from employment with the Town of Hinesburg. As such, the Selectboard authorizes the Selectboard Chair to sign a correspondence on behalf of the Selectboard, to be sent via certified mail to Mr. Mattison on February 14, 2013, outlying said actions, providing reasons for the discharge, informing him of his rights to appeal pursuant to the grievance process outlined in Article 13 of the Agreement between the Town and AFSCME, and informing him of right to meet with the Town Administrator to offer reasons why discharge should not take place for the Selectboard to consider prior to making a final decision regarding his employment with the Town of Hinesburg.***
